- Your booth space is 10'x20'('30) you must provide your own tables, chairs and tent for your booth. Booths cannot place displays outside of the 10' x 20'(30') area of the booth space, this includes signs. (Please make sure you check off the type of power needed.)

- A refuse container must be present in the concession area & its contents properly disposed at the conclusion of the event.
- Water and ice is not provided for Food Vendors by the South Sound BBQ Festival.
- Washington State Food Service Regulation WAC 246-215-120 Sanitary Facilities and Control states: "Food service establishment owners shall dispose of all liquid waste including gray water, mop water, and ice melt into an approved on-site sewage disposal system or in another manner approved by the health officer."
- Vendors are responsible for following local health, fire, and water quality codes. All food vendors with cooking equipment must have 40B: C fire extinguishers serviced within one year of event.
- Any refuse created from your booth needs to be properly disposed of at the conclusion of the event.
- Vendors are permitted to giveaway promotional items, sell retail items & promote their business.
- All Vendors have an opportunity to donate a \$25+ valued item to the event to use for raffles. Please drop off your raffle item when you check-in the day of the event or to the chamber office by 7/10/25 Thank you in advance for contributing your valuable merchandise and/or gift cards to our raffle, which is a highlight for the attendees and an important aspect of the event.
- Times of importance:
  - > Set-Up 6:30-9:30am
  - > Vendors must check-in by 9:15am
  - > All Vehicles removed from the vendor area by 9:30am
  - > All Vendors must be prepared to serve the public by 11:00am
  - > Vendors must remain set-up until 7pm, even if you run out of products
  - >Tear down begins at 7pm, all vendors must leave their space clean at the end of the event.
- Want to be on the Pit Pass (Festival Map) Your completed application must be turned in and paid in full by June 16, 2025.
- Vendors not conforming to any of the above requirements will be required to leave the event immediately.
