Business Vendor Booth Details

- **Booth Space:** Your space is 10'x10' (or 10'x20'). Vendors must provide their own tables, chairs, and tent. All displays, including signs, must fit within the assigned space. (No Power or Water is available for Non-Food Vendor Booths).
- **Waste Disposal:** Any refuse generated from your booth must be properly contained and disposed of at the conclusion of the event.
- **Business & Promotional Activities:** Vendors may sell food & retail items, give away promotional items, & promote their business.
- **Sales Restrictions:** The sale of meals, snacks, or beverages is not permitted. Seasonings and sauces are allowed.
- **Optional Raffle Donation:** Vendors are encouraged to donate an item valued at \$25+ for the event raffle – And gives your business an extra shout out from the stage during the event. Drop off at check-in or at the Chamber office by 7/09/26. Your contribution is a highlight for attendees and greatly appreciated.
- **Times of importance:** Set-Up 6:30–9:30 AM | Check-In by 9:15 AM | Vehicles cleared from street by 9:30 AM | Ready to serve by 11:00 AM | Remain until 7:00 PM | Tear-down 7:00 PM – leave space clean
- **Pit Pass (Festival Map) Deadline:** To be included on the Pit Pass (Festival Map), your completed application and full payment must be received by **June 5, 2026**.
- **Compliance Enforcement:** Vendors not conforming to any of the above requirements will be required to leave the event immediately.
